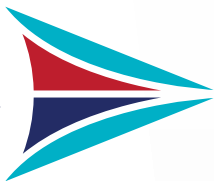

Please note: Changes in vessel registration, including changing Recognized Organizations, ISM company, vessel name, may affect the validity of existing vessel documentation. The Liberian Registry is pleased to offer owners of ships registered in non-convention States the opportunity to obtain WRC, BCLC and/or CLC liability certificates through the Registry's online certification facility, WayPoint, or by directly emailing vesselcertificates@liscr.com

Inmarsat Activations

The Liberian Registry handles all Inmarsat service functions including activation and deactivation of Inmarsat mobile terminals and the issuance of Inmarsat mobile numbers.

A request for activation must be made when:

- A vessel changes flag
- A vessel first enters service (newbuilding)
- A change in equipment details, including ownership of equipment (vessel owner/operator/name change)

What is the procedure for requesting activation?

1. Appoint an Accounting Authority from [Approved List](#)
2. The AA will submit an Inmarsat Service Activation Form (SARF) on your behalf signed by both applicant and the Accounting Authority
**SARF must be signed by both application and the Accounting Authority*
3. Ensure all equipment has been previously deactivated

Iridium Global Maritime Distress Safety System Terminals

Approved Iridium Global Maritime Distress Safety System (GMDSS) terminals may be installed on Liberian flagged vessels for compliance of SOLAS Chapter IV. The Administration must be notified of any Iridium terminals installed on board a Liberian vessel in compliance with International Telecommunication Union (ITU).

What is the procedure for Iridium activation?

1. A [Liberian Registry approved Iridium GMDSS service provider](#) must activate the terminal.
2. The recognized Iridium GMDSS service provider will forward to the Administration the Iridium GMDSS terminal information
3. The Administration will verify compliance with SOLAS Chapter IV requirements.
4. The Administration will log the details in our communication database.
5. An amended radio license will need to be issued to reflect all installed Iridium terminals.

- Liquefied Gas Carrier Cargo Operations Manual
- Oil Discharging Monitoring and Control Systems (ODMCS) operational manuals
- Ship energy efficiency management plans (SEEMP)
- Ship Structure Access Manual
- Ship to Ship (STS) Operations Plans
- Shipboard Marine Pollution Emergency Plan (SMPEP)
- Shipboard Oil Pollution Prevention Plan (SOPEP)
- Volatile Organic Compound (VOC) Management Plans

Vessel Inspections and Audits

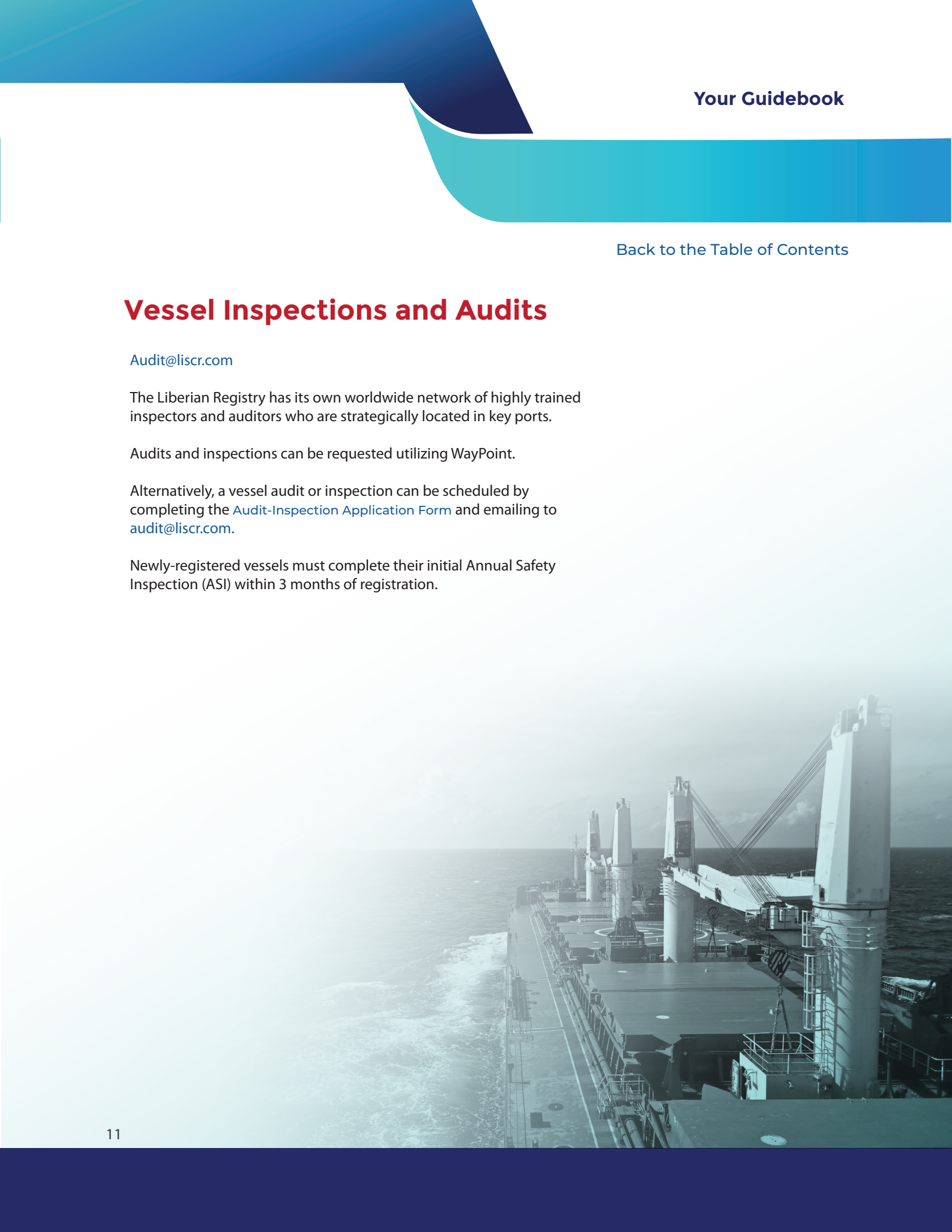

The Liberian Registry has its own worldwide network of highly trained inspectors and auditors who are strategically located in key ports.

Audits and inspections can be requested utilizing WayPoint.

Alternatively, a vessel audit or inspection can be scheduled by completing the [Audit-Inspection Application Form](#) and emailing to audit@liscr.com.

Newly-registered vessels must complete their initial Annual Safety Inspection (ASI) within 3 months of registration.

Combined Block Fee Agreement (C-BFA)

Save time, money, and personnel resources by enrolling in our combined block fee agreement (C-BFA)

The C-BFA is a 5-year agreement that includes the following during the first 5-year cycle:

- Issuance of Declaration of Maritime Labour Compliance (DMLC) Part I
- Review and acceptance of DMLC Part II
- Initial and Intermediate Inspection for a Maritime Labour Certificate
- Intermediate Inspection for certification with MLC 2006
- Unlimited amendments to the DMLC Part I, DMLC Part II, and Maritime Labour Certificate
- Initial and Intermediate Audit for an International Ship Security Certificate (ISSC)
- Unlimited amendments to the ISSC Certificate
- Initial and Intermediate Audit for a Safety Management Certificate (SMC)
- Unlimited amendments to the SMC Certificate

The Liberian Registry also offers the following additional services at discounted rates for vessels enrolled in a C-BFA:

- Interim ISM/ISPS/MLC audit and inspection
- Company Document of Compliance audits
- Shipboard plan review
- Additional MLC inspection or ISM/ISPS audit
- Ship Security Alert System initial or replacement installation verification

Maritime Security

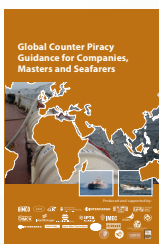

The Maritime Security team has developed comprehensive procedures for implementation and adherence to the International Ship and Port Security (ISPS) Code to help reduce the threat of crimes and attacks against Liberian vessels and their crew.

Ship Security Plans should be submitted to the Security team for review and approval at security@liscr.com

As stated in Marine Notice 01/2022, shipowners and operators of Liberian-flagged vessels employing privately contracted armed or unarmed security personnel must exclusively use an authorized Private Maritime Security Company (PMSC).

Before entering High-Risk areas as defined by [Marine Security Advisory 01/2023](#), please complete and submit the [Anti-Piracy Checklist](#). Experience shows that applying the recommendations on this checklist will assist ships to detect, avoid, deter, or delay piracy or armed robbery attacks.

LRIT

The Maritime Security Team manages the conformance test results of LRIT data and issues Conformance Certificates. An annual conformance test is required for all shipborne LRIT equipment to confirm compliance with the provisions of SOLAS.

Conformance Tests:

For security reasons, all conformance tests shall be conducted directly by the Liberian Administration Authorized Testing Application Service Provider (Testing ASP), Pole Star Space Application Ltd.

Shipborne equipment is required to undergo a new conformance test and a new Conformance Certificate is required to be issued when:

- changes are made to LRIT shipborne equipment
- LRIT shipborne equipment becomes unserviceable
- the Administration has been notified by Polestar that the shipborne equipment is not operating within the parameters of the conformance test report and/or in accordance with the LRIT performance standards
- the affected ship has transferred to the Liberian flag or re-registered under the Liberian flag
- the ship is intended to operate outside the sea area noted on the Conformance Test
- at twelve month intervals, on or before the anniversary date of the conformance test

In the event of ship renaming, a request for an amended conformance certificate can be sent to LRIT@liscr.com

Approved Service Providers

Lifeboat Authorized Service Providers:

The Liberian Registry has authorized service providers to carry out maintenance, through examination, operational testing, overhaul and repair of equipment. A list of currently approved lifeboat authorized service providers can be found on our website at [Lifeboat Service Providers](#).

Inventory of Hazardous Material (IHM) Expert Companies:

In accordance with the guidelines of the Hong Kong International Convention, a valid International Certificate on Inventory of Hazardous Materials (ICIMH) is required to be maintained onboard vessels. Vessels desiring to obtain the International Certificate on IHM must use an IHM Expert Company approved by the Administration. A list of approved IHM Expert companies is maintained on our website at [Inventory of Hazardous Materials \(IHM\) Expert Companies](#).

Approved Service Providers

Approved Electronic Record Books (ERBs):

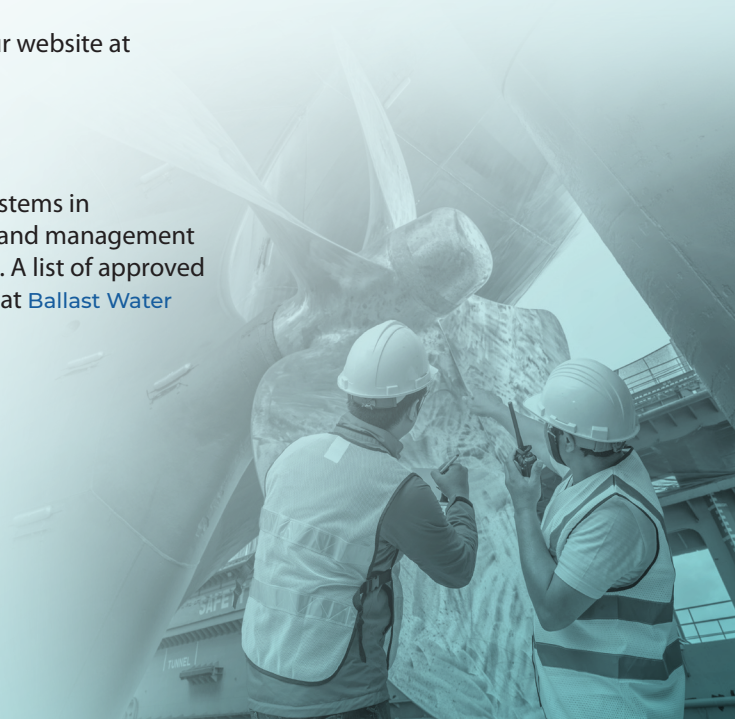
The Liberian Registry allows the usage of ERB to satisfy the mandatory regulatory requirements for:

1. Oil Record Book, Parts I and II (MAROL Annex I, regulations 17.1 and 36.1)
2. Cargo Record Book (MARPOL Annex II, regulation 15.1)
3. Garbage Record Book, Parts I and II (MARPOL Annex V, regulation 10.3)
4. Ozone-Depleting Substances Record Book (MARPOL Annex VI, regulation 12.6)
5. Recording of the tier and on/off status of marine diesel engines
6. Record of Fuel Oil Changeover
7. Record Book of Engine Parameters
8. Record of Navigational Activities ((Navigation Log Book) – SOLAS Chapter V, regulation 28)
9. Record of Engine Room Activities and Parameters (Engine Room Log Book)
10. Record of Radiocommunication Services (GMDSS Radio Log) – SOLAS Chapter IV, regulation 17)
11. Other logs such as Medical Log, Compass Deviation Log
12. Record of Ballast Water Operations (Ballast Water Record Book) – BWM Convention, regulation B-2e

Ballast Water Treatment Systems:

The Liberian Registry has approved ballast water treatment systems in compliance with the International Convention for the control and management of ship's ballast water and sediments, 2004 (BWM Convention).
