I. AMERICAN EXPRESS, VISA OR MASTERCARD

- Select the “Pay by Invoice” if you received a copy of the final issued invoice
- Select the Pre-Payment (No Invoice Numbers) if not received, or if the invoice lists "Pre Order Invoice"

- You may add your PO number or Vessel Name as reference to identify the payment, or if you issued your own work order, include the Work Order number
